#### 2. Submit Comments in person:

There will not be opportunity to provide public comment by remote, telephonic or video-conference means. Comments will be limited to a total of three (3) minutes per speaker for all items on the agenda (including comments made for items not appearing on the agenda), with the presiding officer retaining discretion to adjust time limits as necessary to ensure efficient and orderly conduct of the meeting.
